2. Minutes of the previous meeting:

3. Business arising from the minutes:

A. ARS Strategic Plan

a. Circulate Strategic Planning notes from Port Augusta to Council members *Done*

- ARS Council member. Additional comments on the draft are needed. The draft is to be finalized by the February 2019 council meeting. **(Don to action)**
- **F.** Role Statements for Publications Committee Members All role statements are finalised and up to date.
- **G.** Congratulatory letter to Port Augusta ARS Conference Organising Committee <u>done.</u> Plus David Phelps thanked John Gavin and Kate Forest in person at the National Landcare Conference in Brisbane in September.
- **H.** Updating the 1984 book "Management of Australia's Rangelands" A copy of Ron Hacker's email on costs was sent to ARS Council members. No further action.
- I. Paid ARS Life Membership Logistics of proposal were developed at the Strategic Planning meeting in Brisbane 12th 13th October and draft guidelines have been completed and circulated to Council by Don Burnside.

Comments from Council members included:-

- A flatter subscription structure is needed for younger members
- Subscriptions for paid life members could be handled on a case by case basis
- It needs to be determined if the proposal is being developed for financial or membership reasons (or both)
- A list of pros and cons is needed
- Highlight to members that the subscription is fully tax deductible
- The option of automatic deduction to pay subscriptions could be an option

The guidelines are to be re-worked in light of the points above and reported back to Council by the 2019 AGM (Don to action)

J. ARS Conference Canberra 2019

- **a.** It was felt by Council that the budgeted profit of \$20,000 was too low and that it should be possible to at least match the profit made at the Port Augusta conference. This is to be raised with Mark Stafford-Smith Done
- **b.** Suggested breakeven registration numbers are to be sent to the Organising Committee (**Don to action**)
- **c.** The conference venue is still under construction; therefore conference dates can't be locked in as bookings can't be made.
- **d.** A face to face meeting is planned for early December to sort out media issues, dates, program, keynote speakers, venue, field tours, sponsors & conference organisers.
- **e.** Suggestion by Gus Whyte (email) that a bus be organized to bring graziers from droughted areas to Canberra for the conference.
- **f.** Draft conference program to be sent to Noelene Duckett to go into the next RMN (November edition, or following edition)
- **g.** Mark Stafford-Smith & Graciela Metternicht have been out of the country a lot in recent times, so progress with organising the conference has been intermittent.
- h. Ecological Society of Australia (ESA) conference will be held in October/November 2019; Cathy Waters was approached to consider a "Rangelands" Symposium and suggested that ARS may like to host this. A number of themes were suggested and included carbon farming and total grazing pressure. Contact person is Perpetua Turner University of Tasmania. 6. Reports

6.1 Membership Report (Don Burnside, Acting Membership Director)

15th November 2018

The summary

There are 205 current paid up and complimentary members – termed as 'active' members. Those members from 2017 who have not paid their membership have been shifted to the 'inactive' category.

The detail

Of the 193 members who were financial in 2017, 155 have renewed in 2018. This means that 38 of those 2017 members did not renew, which is disappointing. However, their details are not lost and they can always re-join in the future – and we can encourage them to do so via email.

We have recruited a number of new or re-joined paid members – 16 in total – through this year, which is encouraging. Some of these people who have joined in the last month will have their membership carried through to the end of 2019.

We have 34 complimentary members, being Editors of the Journal, RMN and Social media, the chair of the Publications Committee, Associate Editors and prize winners from conferences. Seven of these complimentary members were prize winners at the RRR or ARS 2017 Conferences, and their complimentary memberships will expire at the end of 2018. They will be encouraged to maintain their membership, with concessional registration at the ARS 2019 conference being an inducement.

The number of Institutional Subscribers to the Journal has remained almost the same for several years. Although the Society does not benefit financially from their patronage, through the Journal, they provide the ARS with very wide exposure across the world.

Notes on financial Report

• *Membership income*. This is behind budget, with 22 paying members not paying for 2018. Full paid members are 169, including those joining during the year.

- **Journal income**. Income has been received for two special issues of the Journal (RRR and Northern Development), and for the 2017 Conference Special Issue which will be published early in 2019. We cannot expect further income from special issues until late 2019 at the earliest.
- Marketing and promotion expenses. Includes payments being made to Wright Social for posts on Social Media (\$120/month) and a payment of \$833 made to Noelene Duckett for her management of the website after Camilla Osborn's resignation and before Russell Grant's recent appointment. Jodie Ward was paid for her period at SME Editor. Further payments made to Wright Social for providing social media and to Ron Hacker and Russell Grant for travel to Sydney for discussions with ZymZen.
- **Journal expenses**. Full year payment of \$18,182 to CSIRO for publication of TRJ under the new contract. This compares favourably with full year payment of \$29,091 under the previous contract. Payment still to be made to Paul Novelly as Editor-in-Chief (EiC) (\$4,000).
- **Newsletter Costs.** Payment of \$2,500 to Noelene Duckett made in November 2018 (hence not shown in above numbers).
- Council costs. Significantly reduced costs for communications due to switch to Webex.
- *Corporate costs.* Represents fines paid to ASIC for Don's late notification of change in Directors (resignation Carol, appointment Bob). Mea Culpa.
- *Honoraria*. Payments have been made to Don Heylen (Book keeper) \$2,750 and Ron Hacker (Chair, Publications Committee) \$2,500.
- Likely outcome for 2018. Profit of \$10,293 until the end of October 2018. Major payments of \$6,500 still be recognised (EiC plus Editor RMN), plus unknown payments for any travel or scholarship grants awarded to be accounted for, and initial payment to PCO for the Canberra Conference. On this basis it is likely that ARS will make a modest loss for calendar year 2018 (perhaps \$4,000?).

6.3 Publications Committee Report (21st November 2018)

The Publications Committee (PC) met on 7 November, 2018. The following matters are forwarded for Council's information and consideration.

a. The Rangeland Journal

Issue 6 of volume 40 is complete and will probably be published by the end of November. This will conclude a successful year for the journal for with the Editor in Chief, Paul Novelly, is to be commended. The journal has received 148 submissions in 2018 to date, compared with annual rates of 125-131 over the last five years. However, volume 40 will run to slightly over 600 pages and this may incur an excess page charge from CSIRO Publishing (at \$110 inc. GST per page). Number of submissions could be expected to drop in future as the EiC has adopted a policy or using the 'Major revision' option for low quality manuscripts in preference to the 'Reject and resubmit' option where possible. If resubmitted after rejection, a revised manuscript is treated as a new submission which in a sense artificially inflates the number of submissions.

The major issue currently facing the journal is the lack of a contacted special issue for the second half of 2019. There is a good chance of concluding a contract with NSW DPI for a special issue on total grazing pressure management to fill this slot but further negotiations are required. A number of other special issues are under discussion, and proposals are likely to be forthcoming, but these are unlikely to be contracted in time for the 2019 time slot.

A virtual issue entitled *Grazing and Biodiversity – The Positive Side* was published on-line in early November and is being promoted widely by CSIRO and the Society's social media channels. (A virtual issue comprises papers on a particular theme drawn from previous issues of TRJ; the collation is made

available free on-line for a limited period. There was a very positive response to our first virtual issue in 2017, with downloads occurring at about five times the usual rate).

A small, voluntary English language editing group has been initiated to provide a service to non-English speaking authors, at the discretion of the Editor-in-Chief. The first paper to use the service - from China – is currently being processed. Experience with this type of service on a voluntary basis may eventually provide an opportunity for a fee-for-service operation run by the ARS.

Council approved out-of-session the extension of Dr Paul Novelly's term as Editor-in-Chief for a further three years, with the option for further extension. As of 7 November Dr Novelly had not been officially advised of this decision and I request that he be notified as soon as possible.

Some of the journal's voluntary editorial support staff have recently come to the end of their appointments. This included all eight Advisory Editors and eight Associate Editors. All have willingly accepted an extension of their term, some Associate Editors commenting that they enjoy working with the Editor-in-Chief. This is a vote of confidence in both the journal and Paul Novelly. A challenge for ongoing management is to find ways to more actively engage the Advisory Editors and some suggestions discussed by PC will be implemented in the near future.

b. Range Management Newsletter

As usual the RMN continues to function under Noelene Duckett's editorship with a minimum bother although good articles are always in short supply. The final issue for 2018 will be published in two to three weeks. A particular need is for information about the 2019 conference which will certainly need to be available for the first issue of 2019 if it cannot be provided for the current issue. Finalisation of Council's position on the discussion paper and recommendations submitted by PC is important for the further development of the RMN.

c. ARS Web site

Russell Grant is finding the web site easy to use and that the functionality for normal management is good. Noelene Duckett and Don Burnside have supported this assessment in relation to their areas of responsibility. However, communication with ZymZen on development or site maintenance issues continues to be poor. There are a number of outstanding matters that have not received timely attention. I will contact Janine Howard in the near future, after collating the issues which are of concern to the web site managers, and try to reach a resolution. It may be that ZymZen consider some of these matters to be outside the services that should provide for their annual hosting fee and I will explore with Janine if this is an issue.

d. Social media

Heidi Wright has maintained three posts per week to Facebook. The number of tweets (and retweets) has varied from 3-10 per week (average 6). We reach 3-4 times as many people by Twitter as we do by Facebook but the numbers reached are still relatively low. This is probably because we do not pay to 'boost' our posts, as recommended in the recent review of social media activity. While the PC requires a report on social media activity for each meeting, and Heidi has provided a report on request (a simple listing of Facebook and Twitter statistics, without interpretation) it appears that she (reasonably) does not see this as part of her contracted services. A short report compiled to our requirements would involve extra cost and I have asked for a quote to provide this information.

Council has approved the offer of the position of Social Media Editor to Sarah Moles but she has yet to advise if she will accept, pending the outcome of an application for a permanent position elsewhere. In the interim, Council has approved extension of the current arrangement with Wright Social until a permanent replacement is found.

e. General

Dr Jocelyn Davies has resigned for the PC with immediate effect to take up an overseas posting. She has been a valued member of PC and brought much experience and insight to the committee's discussions.

The terms of two other members (Don Burnside and Andrew Ash) have recently expired and both have indicated that they will accept an extension for a further three years.

Discussion from Publications Committee report:

A. Social Media

Motion: That the following recommendations in the Social Media report (Hacker & Wright, August 2018) plus additional recommendations 14 & 15 (below) be accepted and adopted by Council:-

- 1. That the objectives for the Society's social media activity remain unchanged.
- 2. That the Social Media Engagement Strategy 2015-17 be updated for 2018-20, retaining the basic elements of the original strategy but incorporating those of the following recommendations which are accepted by Council.
- 3. That Zym Zen be asked to provide detailed information on web site page usage on a regular basis (say 6-monthly).
- 4. That the SME utilise current content from the web site (e.g. TRJ Abstracts, RMN articles) as a basis for social media posts as frequently as possible(consistent with Pillar 1 of the content strategy ARS-centric stories).
- 5. That the SME provide an abridged version of the current report format for each PC meeting.
- 6. That the arrangement with Wright Social be reviewed in October 2018 and that PC (at its meeting on 7 November) make a recommendation to Council for decision at its November meeting
- 7. That PC prepares a profile of ARS for submission to Wikipedia after Council approval.
- 8. That Council establish a Facebook Ad account, to be used at the discretion of the SME to promote specific posts, and install Facebook Pixel at the ARS web site.
- 9. That Council supports the SME to develop a weekly series based on personal profiles to boost engagement and increase relevancy among current and future membership.
- 10. That Council supports the SME to actively seek original and relevant content by promoting opportunities for students to contribute articles to the ARS web site/social media with annual prizes to be won.
- 11. That the SME aim to increase the posting frequency to Facebook to 5 days a week.
- 12. That ARS host Internet forums on specific topics, moderated by the SME or a guest moderator, when opportunities arise.
- 13. That ARS, through the SME, take steps to incorporate social media icons into email signatures and official stationery.
- 14. That the SME use other social media platforms including LinkedIn, YouTube, and Instagram (for graphics) where appropriate.
- 15. That the SME keep abreast of changing trends in social media.

B. Range Management newsletter

<u>Motion:</u> That Council accept and adopt the PC's recommendations 1-8 as outlined in the "Revitalising the Range Management Newsletter" report (Hacker & Duckett) and listed below (with the addition to the second dot point under Recommendation 7) as the basis for development of the Range Management Newsletter.

- 1. The name and format of the RMN remain unchanged;
- 2. Titles of papers from biennial conferences should be published in RMN, with links to the articles on the web site; it is not necessary to include abstracts;
- 3. Efforts should be made to attract 'lay summaries' (generally about one page, including pictures) of papers appearing *The Rangeland Journal*, setting out the practical implications of the work in lay language.
- 4. Formal reciprocal arrangements should be established with a range of other newsletters to share content:
- 5. Opinion pieces should be sought from appropriate individuals relating to topical rangeland issues, both nationally and internationally;
- 6. The current policy of embargoing the current issue until the next issue is produced should be maintained; a pay-per-view option for the current issue is not recommended;
- 7. The resources available to produce the RMN should, as required, be expanded to include
 - An Editorial Assistant (responsible for assisting to solicit lay summaries and monitoring of partner newsletters)
 - State correspondents (responsible for identifying topical issues and soliciting opinion pieces, in conjunction with the Editor) to be trialled for 12 months, then reviewed.
 - Input from Advisory Editors (who would be asked to perform a role equivalent to State correspondents at the international level)
- 8. None of these additional positions should receive an honorarium but individuals should be recognized in an appropriate way (e.g. by having their names published in RMN and possibly provision of a CSIRO gift voucher or the like annually).

D. The Rangeland Journal

The following points were discussed:-

- ARS needs to commission papers to increase citation of TRJ articles
- Leigh Hunt's 2014 journal article "Principles and guidelines for managing cattle grazing in the grazing lands of northern Australia: stocking rates, pasture resting, prescribed fire, paddock size and water points a review" was the most cited TRJ article in 2015.
 - A similar paper is needed on the management of the southern rangelands
 - Provide funds for a suitable person to write this paper
 - o Include the paper in the special issue of TRJ on Total Grazing Pressure
 - This proposal is to be discussed at the next Publications Committee meeting and reported back to the next ARS Council meeting (Don to action)
- Other possible special issues of TRJ
 - Drought Management contact details of suitable people who can contribute to this special issue to be given to Ron Hacker
 - Eg Jackie Wilcox at EcoSciences Precinct, Brisbane (Andrew Ash to action)
 - A person from NSW DPI (Cathy Waters to action)
 - o Wambiana grazing trial (Qld) in 2020 with funding from MLA
- The 5 spare copies of each edition of TRJ (including those held by Anabel Walsh) are to be redirected to the secretary. (Don to action)

7. General/New Business:

a. Promotion at the Nairobi 2020 IRC/IGC of the ARS and Australia's bid for IRC 2025

There has been a joint booth promoting both TRJ/ARS and CSIRO Publishing which is staffed by people from both ARS (conference delegates) and CSIRO in the past. CSIRO has funds to promote TRJ including the cost of covering the Editor-in-Chief's attendance at the IRCs. Provided Australia is successful with the bid to host IRC 2025, ARS Council will be keen to promote the congress in Nairobi. Details of the promotion are yet to be developed. Council to advise Ron Hacker of this decision. (**Bob to action**)
